



TERMS AND CONDITIONS

This agreement contains the entire understanding between the Tilted Frame Photography and the client. It supersedes all prior and simultaneous agreements between the parties. The only way to add or change this agreement is to do so in writing, signed by all parties. In the event that any part of this agreement is found to be invalid or unenforceable, the remainder of this agreement shall remain valid and enforceable. Any agreement to waive one or more provisions of this agreement or any failure by one or both parties to enforce a provision of this agreement shall not constitute a waiver of any other portion or provision of this agreement.

1. All photography services supplied by the named PHOTOGRAPHERS above are in association with Tilted Frame Photography.
2. Images will be supplied to the client within one month of the event as .jpeg files.
3. The photographer is under no obligation to supply .raw files. Any arrangement will be made on an individual basis and additional fees may apply.

5. You are free to share, copy, and print the work as much as you like for non-profit purposes. However, it must be attributed to Tilted Frame Photography using the watermark or a caption (for example "[PHOTOGRAPHER], Tilted Frame Photography)
6. In the unlikely event that Tilted Frame Photography must cancel, we will give as much notice as possible, return all fees, and suggest alternatives wherever possible.
7. Liability is limited to total contract price.
8. In the unlikely event that digital files are damaged, lost, or stolen for reasons beyond the control of Tilted Frame, a refund will be provided based on the proportion of images lost.
9. Tilted Frame is unable to replace lost files beyond 3 months the final delivery. Additional fees may apply for replacement or additional DVDs.
10. Unless you request otherwise, we may use some of your images on promotional material.

11. Please be aware that images are subject to creative variation and we are unable to emulate a photographic aesthetic that does not bear close resemblance to the photographer's own style.
12. Image editing is at the discretion of the photographer. Images that are not of high quality or are technically substandard are removed as part of the editing process.
13. A 50% non-refundable deposit is required 1 month in advance of the event. Remaining balance must be made within one month after the event or before photos are released. Fees can be paid by cheque (made payable to the photographer), bank transfer, or cash.
14. Failure to make payment will result in the termination of this agreement with no further obligation.
15. Tilted Frame Photography reserves the right to terminate this agreement with no further obligation if the photography experiences inappropriate, threatening, hostile, or offensive behaviour from person(s) at the event.
16. The photographers are not responsible for compromised coverage due to causes beyond their control including, but not limited to: obstruction by guests, late clients, weather conditions, location restrictions, lighting conditions.

Graduation

1. We are unable to extend the length of the graduation photography sessions. Photography will begin and end at the scheduled times.
2. Notifications of changes must be made in a timely manner.
3. The client has the right to rearrange the appointment subject to availability.
4. In the event of inclement weather the client may rearrange to a drier location.
5. The client must provide their own gown and hood unless otherwise arranged by the photographer.
